

Applications are sent to Regional Utility Offices who assign the application to staff to review. Once received, applications will be reviewed to ensure they are complete, accurate and meet WSDOT standards and requirements. This initial review may be an iterative process with multiple revisions required by the utility and waiting time can vary depending on how responsive the utility is during this initial review. After the initial review and the application is considered complete, Regional Utility Office staff send the application to regional specialty groups for review, which may include approvals such as for access breaks and traffic control plans. If an application requires a variance to a policy or standard there will be additional approvals needed prior to issuing the permit or franchise. Depending on the variance this may require region, Headquarters, or FHWA approval. Once the specialty review is complete and all concerns are mitigated the utility accommodation will be finalized, approved and issued to the utility by Regional Utility Office staff. The utility has 1 year to begin construction and completion within 3 years.

The processing time was established by using weighted averages to account for the difference in quantity and complexity of applications received by different regions. While averages were able to be determined by this method, it is challenging to represent an accurate number that reflects the different dynamics present in six regions. Utility installations vary greatly depending on the facility type and the complexity being proposed. As these are sometimes large facility construction projects, they offer tremendous opportunity for impacts to the safety of the traveling public. Extensive review from other support disciplines is essential. However, other disciplines at WSDOT do not have the capacity or resources to always respond to the fluctuating demand of application review from third-party utility owners seeking accommodation of the State's right-of-way. Recently the HQ Utility Office, with consultation of region offices, published a set of Accommodation Guidelines online to assist in the application submittal process and to manage expectations of utility applicants. There are ongoing efforts to review and improve the process, but further analysis is needed to determine if improvement in processing time and/or resource needs can be addressed. An online utility permitting system would greatly improve the application process, also following other State DOTs. However, prerequisites to an online permitting system are a real estate map displaying WSDOT's owned right-of-way and online payment capabilities, as examples.
